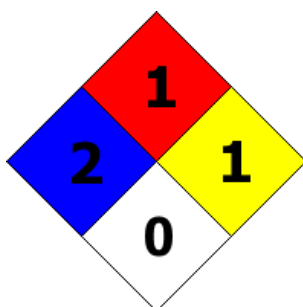

After inhalation:

Methods and material for containment and cleaning up:

If in a laboratory setting, follow Chemical Hygiene Plan procedures. Place into properly labeled containers for recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. SECTION 7: Handling and storage

Precautions for safe handling:

Minimize dust generation and accumulation. Wash hands after handling. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. Use only in well ventilated areas. Provide ventilation for containers. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Store with like hazards.
